- 1. Charges applicable from 1 July 2024 and are subject to change without notice.
- 2. All prices exclude G.S.T.
- 3. All prices include the Section 99 Government Waste Levy.
- 4. All vehicles are weighed in and out on our fully certified weighbridges to calculate the net weight disposed.
- 5. Prices are based on the waste type.
- 6. All waste will be inspected at each site by a Waste Inspector both before and during unloading.
- 7. Non-account customers paying by cash, credit card or EFTPOS will be required to leave suitable identification at the weighbridge before tipping.
- 8. All goods invoiced as per signed weighbridge docket. No classification disputes will be accepted.
- 9. Our current "Conditions of Sale" and credit terms apply.
- 10. Benedict Recycling does not accept any non-conforming or hazardous materials that do not appear on our EPA licence, including but not limited to: liquid waste, asbestos or putrescible waste.
- 11. Minimum transaction fee applies for all waste streams, please refer to our Gate Rates located at www.benedictrecycling.com.au for rates associated with each recycling facility.
- 12. NRECW will be charged at net weight x your light demolition rate.
